- (1) In future if it is found that you have submitted wrong information to the Government to obtain the no objection certificate, or the instructions issued by Punjab Government are not being adhered to by you, and the conditions of affidavit are not being obeyed, in that case this no objection certificate can be withdrawn at any time.
- (2) It will be compulsory to educate Punjabi in your school and CBSE New Delhi will make arrangement to examine Punjabi in these schools, or otherwise the no objection certificate will be taken back immediately.
- (3) The school management will adhere to the notifications issued by Punjab Government as per R.T.E. Act,2009 and the rules framed under the R.T.E. Act,2009.
- (4) The school management will be bound to pay the school staff i.e. teaching and non teaching the Govt. scales of salary as well as other allowances through account payee cheques, or otherwise the no objection certificate will be taken back.
- (5) You yourself and your management will ensure that whenever any information is asked by your District Education officer or by any other senior officer of Education Deptt., the same will be submitted and the required cooperation will be provided to him.
